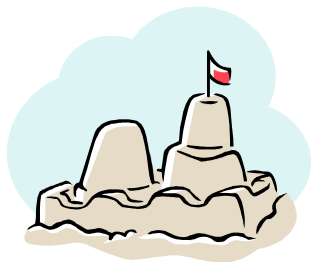


SAND CASTLES & SCULPTURES RULES AND REGULATIONS CHEESEBURGER IN CASEVILLE
